

■Graduation Postponement on and after 3rd year in the Master’ s Program, on and after 4th year in the Doctoral Program <論文減額: Thesis Reduction>

The amount of tuition and fees will be reduced automatically per semester for those who meet all of the following conditions. Application for a reduction is not necessary.

- a) Those who have been studying beyond the standard residence requirement(※).
- b) Those who have satisfied the prescribed requirements stipulated in the graduate program except master’ s thesis, graduation project or doctoral dissertation.

(※) The standard residence requirement is 2 years (4 semesters) for the Master's Program and 3 years (6 semesters) for the Doctoral Program.

■Reduction for Juris Doctor Program whose graduation is postponed with 12 credits remaining <残余12単位減額>

The amount of tuition and fees will be reduced automatically per semester in either of the two cases. Application for a reduction is not necessary.

- ① At the beginning of a new semester, those who have fulfilled residence requirements, excluding the period of Leave of Absence or suspension from the university, and have less than 12 credits to graduate.
- ② At the beginning of a new semester, those who have fulfilled residence requirements, excluding the period of Leave of Absence or suspension from the university, and studied abroad before the relevant semester with less than 12 credits to graduate as a result of transfer of credits.

■Tuition reduction during Study Abroad

- (1) There are two types of Study Abroad, “Sophia Exchange Program” and “General Study Abroad”. Students studying abroad on “Sophia Exchange Program” will pay tuition and fees only to Sophia University, but “General Study Abroad” students (those who study abroad on their own) must pay tuition and fees both to Sophia University and to the overseas institution.
- (2) Fees to be paid in case of extension of Study Abroad period
If a student wishes to extend his/her study abroad period beyond one year and the permission is granted, the tuition and fees shall be reduced. The reduction will be made according to the “exemption of fees” during a Leave of Absence.
